#### Q1. WHO ARE THE OWNERS/DEVELOPER OF ELITE VILLA ESTATE?

A.EINSTEIN CONSTRUCTIONS AND REAL ESTATE. A Leading Construction and Real Estate Company with Head office in Benin City, Edo State.

Q2. WHAT TYPE OF TITLE DOES EINSTEIN CONSTRUCTIONS AND REAL ESTATE HAVE ON THE LAND?

A. Deed of ASSIGNMENT, CofO (in view) and Niger State Government Approved Survey Plan

O4. ARE THERE ANY ENCUMBRANCES ON THE LAND?

A. The land is free from every known Encumbrances

#### Q5. WHAT IS THE PAYMENT STRUCTURE?
